WNCC LAY ORGANIZATION MEETING

SPRINGDALE AME CHURCH, BURLINGTON, NC APRIL 14, 2018

The meeting was called to order by President Penny Oliver at 10:00 a.m.

Sister Jessie Caldwell led devotion; the opening song, page #243, "Down At the Cross." We were led in Prayer by Sister Myrtle Mayo, afterwards, the 23rd Psalms was read by Sister Caldwell and each verse was explained.

Welcome: Reverend Robert Goode, Pastor Springdale and Penny Oliver, Local Lay President. The Agenda Packet was distributed upon payment of the \$5.00 registration fee and the meeting proceeded accordingly. Several **important announcements** were listed on the front page of the Agenda. Elections: Brother Dwight, District Lay President, was presented to the Body to conduct the WNCCLO Election of Officers. He called Brother Kenneth Woods and the Nomination Committee to present the slate of officers. Brother Dale Wragg read the Nomination Committee' report and we received a motion by Brother John Smith, to accept the report as read, with the exception of Sister Renee White's request to President Oliver and the Nomination Committee to have her name removed from the ballot, (**See attachment #1**); seconded by Brother Adolphus Kelly and Sister Myrtle Mayo; Unreadiness by Brother McAdams. (After being recognized by President Patterson, Brother McAdams asked for his own understanding, "are the officers under the obligation to abide by the By-Laws, Discipline and Roberts Rule of Order?") President Patterson replied, yes.

After much discussion Sister Emma Devine moved that since there were no contested offices that the Recording Secretary, verbally cast the unanimous vote for the names on the ballot. It was seconded by Sister Starr Battle. The motion carried and Diane Foy, Recording Secretary of the WNCCLO verbally cast the unanimous vote for the slate of officers for 2018-2020. Upon the promptness of Sister Star Battle, the vacant positions for **First Vice President**, **Parliamentarian** and the **Young Adult Representative** will be addressed by the end of the month.

Election Delegates to 17th SEDLO Convention

President Oliver presented Brother John Smith to conduct this part of the election. In order to determine the persons who are eligible to vote and in good standing, our Credentials/Membership Chair, Niki Allen, called the names of the churches and the number of paid registrants eligible to vote, which totaled **54**. Our instructions were to vote on **6 persons** in addition to our President; Director of Lay Activities and Young Adult Representative (open position/elect a youth), automatically will attend.

Brother Smith opened the floor for nominations of delegates to the Biennial they were;

It was moved by Betty Duell that the nominations be closed on the eleven (11) said names; seconded by various persons. Brother Smith read the expenses cited for each delegate, totaling 450.00 /each delegate attending. Two Tellers and two clerks volunteered, that were involved in the voting process. Each nominee was asked to stand as their name was called for recognition by the Lay Body. Further instructions were given by Brother Smith that you could vote for no more than six (6) persons, more than that your ballot would be considered null/void. (54 voting = 27 +1 = 28)

Sister Starr Battle moved that *the six (6) highest vote getter's*, represent us from the conference; many seconded this motion.

Brother Dwight Patterson moved we determine our **Alternates** the same way, the next highest vote getter; seconded by Sonia Barbre; majority has it and had one to oppose, so moved.

While waiting for the final count of the Delegates, President Oliver entertained a motion on the number of disciples we should order, taking under consideration some of the churches have been supplied by the Elder. Sister Devine moved that two (2) boxes should be ordered and was seconded by various persons; cost \$30.00/each. The vote was unanimous and carried. Payment should be made to Director of Lay Activities, Sister Jackie Kanipe and she makes deposit to treasury.
